# Putnam Valley CSD Proposes 2014-2015 Budget Tax Levy Increase Falls Below Tax Cap At 0.76%


- Funds a science research program at the High School
- Includes staff development for teaching the Common Core
- Restructures administrative positions to enhance instruction
- Provides a student support specialist at the High School
- Restores Driver Education Program with no impact on budget
- Enhances Elementary School security by funding a patrol officer
- Funds a second foreign language at the High School
- Eliminates 3.0 teaching positions due to enrollment changes
- Includes online courses at High School
- Replaces geothermal manifold at Middle School
- Replaces sewage ejection system at High School and Middle School

# A Letter to the Community

In Putnam Valley, we embrace the challenge of educating students to become lifelong learners and productive citizens in a diverse global society. At the same time, we are mindful of the need to hold the line on taxes.

To these ends, we have proposed a fiscally conservative budget that places the child first and foremost, and moves Putnam Valley's educational program forward. With input from students, parents, senior citizens, teachers and others, we have developed a budget that reduces spending by more than \$470,000 while enhancing educational offerings.

The proposed \$48.1 million budget for 2014-2015 calls for adding .2 math positions to the Middle School and reducing 3.2 teaching positions in response to shifting enrollment, adding an authentic science research program at the High School, adding a student support specialist to the High School, restoring a second foreign language offering at the High School, enhancing professional development to assist with implementation of the Common Core curriculum, adding a safety patrol officer at the Elementary School and piloting online learning experiences for high school students.

By reconfiguring administrative responsibilities, the District will be able to target spending to student success. The plan calls for replacing the director of pupil personnel with an assistant superintendent for human resources and pupil personnel; replacing the assistant superintendent for business with a treasurer; replacing the senior account clerk and tax collector with an accountant; and replacing the position of transportation, operations and maintenance supervisor with a director of operations, transportation and technology. The end result will be an administrative team with a greater focus on educational initiatives and instruction.

As a result of declining enrollment, the proposed budget calls for reducing teaching staff by 3.0 full-time equivalent positions, with a savings of \$410,000. The reductions would be as follows: 2 retirements; .2 high school social studies; .4 elementary physical education; .2 elementary music; .2 elementary art; and .2 elementary technology. At the Middle School, a .2 math position is being added to ensure appropriate class size and academic support.

In order to ensure the proper maintenance of school facilities, the proposed budget also includes two capital projects: the replacement of the geothermal manifold at the Middle School, and the replacement of the Middle School and High School sewage ejection pumping systems. The cost for these projects will be offset by monies from the debt service fund. We believe the proposed 2014-2015 budget maximizes our programs and reflects the priorities of the community.

- PVHS students Blendi Muriqi, Lucas Fishbein and Dan Munson are finalists in the NY Young Entrepreneur Challenge for their creation of Volunteer Access.com.

### **Did You Know?**


- Putnam Valley CSD will save \$257,670 by refinancing bonds for previous capital projects.
- The Town of Putnam Valley did work on athletic fields for the District at no cost.
- The District spent \$0 on heating oil for the middle and high schools thanks to the geothermal system.
- The District will save \$216,716 over five years by purchasing laptops through PNW BOCES.
- Putnam Valley CSD shares services with other public entities for transportation, fuel oil and the purchasing of supplies and materials in order to decrease costs.







### Where the Money Comes From



#### Real Property Tax Levy \$36,125,964

75% of budget revenue comes from property taxes. This is an increase of 0.76% over last year.

#### Local non-tax sources \$1,012,300

Additional revenue comes from rental of the performing arts center, fees for summer camp, tuition for out-of-district students, sales tax and interest earnings from investments.


#### State and Federal Sources \$9,837,815

The anticipated aid represents an increase of 6.97% or \$641,373 over last year.

#### **Appropriated Fund Balance \$1,179,068**

This includes a \$750,000 appropriated fund balance, \$165,000 appropriation of reserve for retirement contribution, and \$264,068 advances from other funds, which offsets a transfer to the capital fund for accounting purposes.

# Where the Money Goes



#### Instruction \$25,954,742

This includes costs for teachers, instructional media, pupil services, instructional improvement and special apportionment programs.

#### Transportation \$2,813,069

This reflects the cost of in-district and out -of-district transportation as required by law.

#### Debt Service & Interfund Transfers \$3,036,156

This includes payments of principal and interest on money borrowed for capital projects.

#### Benefits \$12,228,500

Includes mandated costs for retirement, social security, Medicare, Health and Welfare and other related insurance costs.
