I. ABOUT THIS RFP:

The Putnam Valley Central School District requests unit cost pricing to perform Construction Testing and Inspection Services for the following Projects as described below:

- Putnam Valley High School Wellness Center Addition Project.
- Putnam Valley Middle School Addition and Alterations Project.
- Putnam Valley Elementary School Alterations Project.

The projects listed above are included in an overall \$14.8M Capital Improvement Bond approved by voters on December 4, 2018. Proposals will be based on providing services throughout the 2020 and 2021 years, with fixed costs provided through the RFP response. A list of services requested, are provided within this RFP.

SPECIAL INSPECTION AGENCY REQUIREMENTS

The Special Inspection Agency must be approved and meet all applicable requirements of the NYS Department of State Division of Code Enforcement Administration (Hereafter referred to as NYSDSDCEA). All equipment used must be adequate to perform required tests and all employed personnel must be experienced and educated in conducting, supervising and evaluating tests and/or inspections. Please review Special Inspector Minimum Qualifications prior to submitting a proposal. Proof of qualifications must be submitted to the Owner prior to award.

All inspections must be documented with reports indicating that all work was done in conformance to approved construction documents, and be furnished to the Code Enforcement Official, Owner, and Design Professional. Any discrepancies must be documented appropriately and reported, as well as corrections of it must also be reported to the Code Enforcement Official, Owner, and Design Professional.

Where (a) (1) (2) and (3) above have not been complied with, the bid shall not be considered for award not shall any award be made unless the head of the purchasing unit of the political subdivision, public department, agency or official thereof to which the bid is made, or his designee, determines that such disclosure was not made for the purpose of restricting competition.
