- 3. If you want the ballot mailed to you, return the application by 4:00 p.m. on May 13, 2014, to the District Clerk.

- 5. Please be advised that no person can have two legal residences for voting purposes. It is not enough to own property or lease a place of business in Putnam Valley. You must also qualify as a legal resident.
