INSURANCE AGREEMENT - USE OF FACILITIES

- 1. Notwithstanding any terms, conditions or provisions, in any other writing between the parties, the facility user hereby agrees to effectuate the naming of Putnam Valley Central School District as an additional insured on the user's insurance policies, except for Workers' Compensation and N.Y. State Disability Insurance.
- 2. The policy naming Putnam Valley Central School District as an additional insured shall:
 - a. Be an insurance policy from an A.M. Best rated A- or better insurer licensed to conduct business in New York State. A New York licensed and admitted insurer is strongly preferred. The decision to accept non-licensed and non-admitted carriers lies exclusively with Putnam Valley Central School District and may create significant vulnerability and costs for the District/BOCES.
 - b. State that the organization's coverage shall be primary and noncontributory coverage for the Putnam Valley Central School District, its Board, employees and volunteers with a waiver of subrogation in favor of the Putnam Valley Central School District.
 - c. Additional insured status shall be provided by standard or other endorsements that extend coverage to Putnam Valley Central School District for both on-going operations (CG 20 26) or equivalent. The decision to accept an endorsement rests solely with the Putnam Valley Central School District. A completed copy of the endorsements must be attached to the certificate of insurance.
- 3. The certificate of insurance must describe the services provided by the facility user that are covered by the liability policies.
- 4. The facility user agrees to indemnify the Putnam Valley Central School District for any applicable deductibles and/or self-insured retentions.
- 5. Minimum Required Insurance:
 - a. Commercial General Liability Insurance

Statutory Workers' Compensation (C-105.2 or U-26.3); and NYS Disability Insurance (DB-120.1) for all employees. Proof of coverage must be on the approved specific form, as required by the New York State Workers' Compensation Board. ACORD certificates are not acceptable. A person seeking an exemption must file a CE-200 Form with the state. The form can be completed and submitted directly to the WC Board online.

6. The facility user acknowledges that failure to obtain such insurance on behalf of the Putnam Valley Central School District constitutes a material breach of contract. The facility user is to provide the Putnam Valley Central

School District with a certificate of insurance, evidencing the above requirements have been met, prior to the event.
